**Participants:** Each national federation may enter a maximum of 12 fencers. The organizing country may enter up to 20 fencers plus the number needed to make up the poules.

**Entry:** Open to all fencers with valid 2021-2022 FIE license.

No fencer is allowed to participate in an official event of the FIE unless they are at least 13 years old on 1<sup>st</sup> January in the year of the competition.



Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31<sup>st</sup> December of the year preceding the year in which the competition takes place (cf. o.80).

Entries of fencers, teams and referees can only be made at the FIE website, [www.fie.org](http://www.fie.org), respecting the deadlines specified in the FIE rules (cf. o.54): 7 days before the competition at the latest (midnight Lausanne time).

**Entry fee:** Individual competition: 25 €. It will be paid at organizer in the registration.

**Referees:** Participating countries must be accompanied by referees with FIE A, B, or P licenses as bellow (cf. t35).

Delegations not respecting the quota must pay a fine of 1.000 € per referee.

1 to 4 fencers	No obligation to provide referee
5 to 9 fencers	One referee
Ten or more fencers	Two referees

**Formula:** One qualifying round of poules, a direct elimination table to qualify for a final by direct elimination (cf. o.35 – o.41).

**Doping Control:** This will be carried out according to the FIE rules.

## **Entry in Spain:**

All passengers arriving in Spain by air or sea, including those coming in transit to other countries, must complete a Health Control Form before departure and obtain their QR to present it at boarding and health controls on arrival in Spain:

- By air: via the website <https://spth.gob.es> or the Spain Travel Health - SpTH- application (Android, iOS).

In addition to the Health Control Form, passengers **must present a certificate or document certifying vaccination, diagnostic test for active infection (PDIA), or recovery from COVID-19**. These certificates will be different if issued in the European Union (EU Digital COVID Certificate) or a third country.

COVID-19 certificates of vaccination, diagnostic tests or recovery issued by countries with which the EU has established equivalence will have the same status as an EU DCC. The accepted vaccines are those produced by Pfizer-Biotech, Moderna, Astra-Zeneca, Jansen / Johnson & Johnson, Sinovac, and Sinopharm, which are those that, at the moment, are authorized by the European Medicines Agency or are included in the list of use of emergency of the World Health Organization.

The Spanish High Council of Sports will issue the corresponding certificate if an athlete does not have any of these documents (vaccine or diagnostic test or COVID recovery certificate) and meets the requirements. For that purpose, we will need the following data:

- name and surname,
- passport number,
- and country from which you are traveling.

### **COVID19 Protocol:**

Following the rules of the Spanish government and applying the FORMIR guidelines of the FIE, the following protocol will be enforced:

#### **1. Rapid Antigen Test (RAT)**

Every participant must undergo a Rapid Antigen Test (RAT). The FIE subsidizes this operation. The tests are free to athletes and referees. Supplementary people must pay for the tests.

Identification of tested people is made via a bracelet. Losing the bracelet will require retesting for a fee (25€).

Being present in the weapon control and the competition without a bracelet is associated with not being controlled. It is an infringement of covid regulations and may be pursued by law enforcement. Authorities will be able to handle it at any moment.

Also, note that the validity of the RATs done at the competition is only valid for the event.

#### **2 . Departure Test**

If you need a departure test, you will need to make a reservation with the OC. The tests cost 90€ and will be at your charge.



Tests will be done on Friday 21.01.2022 between 09:00 and 17:00 (results available before 14:00 next day) and Saturday 22.01.2022 between 09:00 and 19:00. (results available before 14:00 the next day).

These timetables could be modified if the PCR requested justified renting a mobile laboratory.

To guarantee that we will handle the required testing volume, you need to obligatory communicate the number of the tests needed by November 29<sup>th</sup>, 2021 latest.

We will then confirm this number and send you a form where you will need to put in the names of the people to be tested. You will need to send us this form by December 8<sup>th</sup>, 2021 latest.

No test can be guaranteed that had not been registered within the deadlines.

The Laboratory EUROFINs MEGALAB conducts departure tests.

## **2. Positive RAT**

The OC must transmit the entire dataset of every person who tested positive to the authorities. Legislation requires that persons tested positive be isolated immediately. The isolation will last until the authorities lift it or a negative PCR test is available.

If a RAT returns positive, the tested person must immediately go to his room. If there is enough time, a PCR test will be done to control the result of the RAT.

No PCR can be done on Friday after 17:00.

Hence if a person tests positive at a RAT after these deadlines, the result is final, and the person must stay in the room until further notice.

**Participants:** Team participation is open to all countries and limited to one team per weapon per country.

**Entry:** Open to all fencers with valid 2021-2022 FIE license.

No fencer is allowed to participate in an official event of the FIE unless they are at least 13 years old on 1<sup>st</sup> January in the year of the competition.

Fencers taking part in all the official FIE Junior competitions, individual or team, must be under 20 years old at midnight on 31<sup>st</sup> December of the year preceding the year in which the competition takes place (cf. o.80).

Entries of fencers, teams and referees can only be made at the FIE website, [www.fie.org](http://www.fie.org), respecting the deadlines specified in the FIE rules (cf. o.54): 7 days before the competition at the latest (midnight Lausanne time).

For team entries, the names of the fencers making up the teams may be changed, by informing the organizers, up to the day before the competition, at the latest at the end of the quarter-finals of the individual competition. However, a replacement can be made after this stage, and at





the latest at the end of the individual event, in the case of injury or illness duly certified by the competition medical doctor.

**The entry fee for the team competition is** 150 €, to be paid at the organizer when registration.

**Formula:** Integral direct elimination with a direct elimination table, incomplete. All places in the table up to 16<sup>th</sup> place will be fought for. From 17<sup>th</sup> place onwards, teams will be classified, within each round of the table, according to their initial position in the table. The first four teams will be placed in the direct elimination table according to the current official team ranking of the FIE (cf. o.86); the remaining ranked teams will be placed in the table by drawing lots of pairs. The teams that are not classified will occupy the last places in the table and will be separated by drawing of lots (cf. o.42 – o.47).
